

- 7 Specific flights and accommodations are subject to availability and will be assigned by CBE. Generally, our promotional flights depart between 3PM and 10PM and return between 6AM and 1PM. All flights return two days after departure date.
- 8 Both travelers must be 21 years of age or older. This certificate is invalid if sold or bartered and is non-transferable.
- 9 This certificate does not include a required \$75 per person reservation fee, government-imposed taxes, baggage fees, transfers, meals, or any incidental expenses such as, but not limited to: phone calls, gratuities, resort fees or entertainment. Hotel may require a credit card imprint or deposit upon check-in to cover incidental expenses.
- 10 Government imposed taxes (approx. \$40 to \$75 per person) are the sole responsibility of the travelers. TERMS & CONDITIONS

- 1 This certificate is valid for round-trip air transportation and up to two nights accommodations for two adults, 21 years of age or older. This certificate provides accommodations in one of over 600 US locations that include the following hotel groups and their subsidiaries: Hilton, Hyatt properties, Holiday Inn, Carlson, Choice or Marriott properties. All accommodations are assigned by CBE, requests for specific accommodations will not be accepted.
- 2 To register, you must fully complete this certificate and mail it to Casablanca Express (CBE) with a refundable \$100 Validation Deposit within 120 days from the date of issue. All payments must be paid by Money Order or Cashier's Check. Payments must be in US funds and drawn on a US bank. Validation Deposit will be refunded to you 30 days after travel is completed. Only original certificates will be honored. We recommend you retain a photocopy for your records.
- 3 Within 30 days of your registration being processed you will be mailed a reservation letter that you must complete with your requested departure dates and mail to CBE along with the required \$75 per person reservation fee. The required \$75 per person reservation fee is fully refundable until your departure date is confirmed, once a travel date is confirmed this fee will be non-refundable. All travel must be completed within one year of the registration date. Call customer service at (800) 315-2065 if your reservation letter is not received within 30 days.
- 4 You must choose a Monday, Tuesday or Wednesday departure date. You must provide three departure dates at least 60 days in advance of your first date and 30 days between subsequent dates. You must provide at least one alternate destination. All reservations are subject to availability. Travel may not be available during major holiday/convention periods and certain destination specific events.
- 5 All reservations must be submitted to CBE in writing through the mail. After you arrange your departure dates you will receive a confirmation letter with your assigned date advising you of the deadline for payment of a Tax Deposit for government imposed taxes. Your departure date will not be deemed confirmed unless CBE receives your signed confirmation letter with the required Tax Deposit by the deadline. Once a valid departure date is assigned no changes or reschedules are allowed.
- 6 Round-trip air transportation must originate from the nearest valid airport to your home and travel must be to a valid airport. Valid airports include: Atlanta, Austin, Baltimore, Boston, Charlotte, Chicago (IAH or MDW as assigned by CBE), Cincinnati, Cleveland, Columbus, Dallas, Denver, Detroit, Fort Lauderdale, Fort Myers, Hartford, Houston (HOU or IAH as assigned by CBE), Indianapolis, Kansas City, Las Vegas, Los Angeles, Memphis, Miami, Minneapolis, Nashville, New Orleans, New York Area (EWR, JFK or LGA as assigned by CBE), Ontario (ONT), Orange County (SNA), Orlando, Philadelphia, Phoenix, Pittsburg, Portland (PDX), Raleigh-Durham, Sacramento, Salt Lake City, San Antonio, San Diego, San Francisco Bay Area (OAK, SFO or SJC as assigned by CBE), Seattle, St. Louis, Tampa, Washington DC Area (DCA or IAD as assigned by CBE).
